## What is this product?

Type This product is a non-UCITS investment fund. It isintended for retail investors and is structured asa Retail Investor AIF (Alternative Investment Fund) . The minimum initial subscription and subsequent subscription amounts are set at €10,000. The product's return depends on the performance of the underlying assets. Capital is at risk in respect of this product.

#### **Objectives**

**Product objectives** The Fund aims to achieve long term growth on your investment. This is achieved via asset allocation i.e. the allocation of the Fund's portfolio between equity securities, debt securities and collective investment schemes.
