

# Gresham House Commerical Property Fund

The Gresham House Commerical Property Fund (the Fund) is a sub fund of the Gresham House Investments ICAV which was authorised by the Central Bank of Ireland in November 2016.

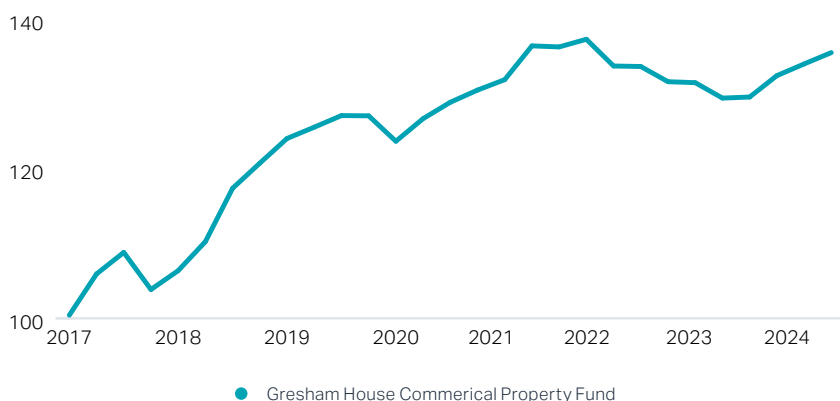
The Fund invests in office, retail and industrial properties in the greater Dublin area and major regional urban centres. The properties will typically be let on long leases with sound financial covenants. Property investments will typically be in the €5mn to €15mn range and the Fund will be valued independently and deal on a quarterly basis.

## Fund objective

The Fund aims to achieve long-term growth on your investments by investing in a portfolio of commerical properties primarily in Ireland. The Fund may utilise borrowings to fund property acquisitions.

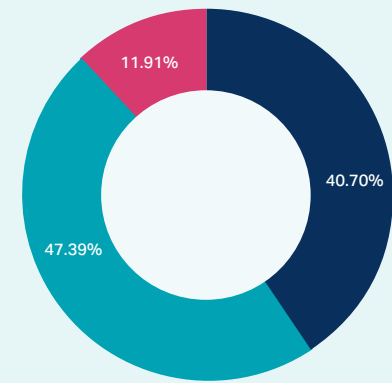

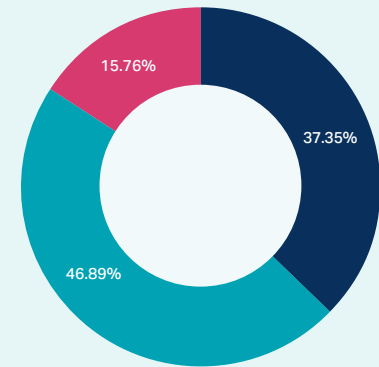
## Sector split by income
