

# UK Smaller Companies Fund

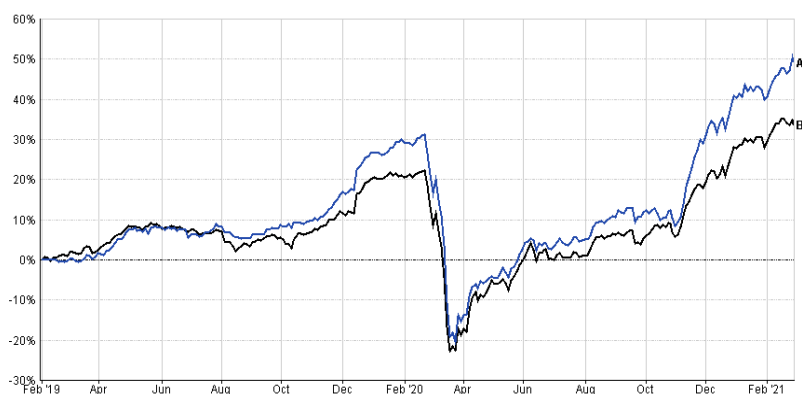
## Fund objective

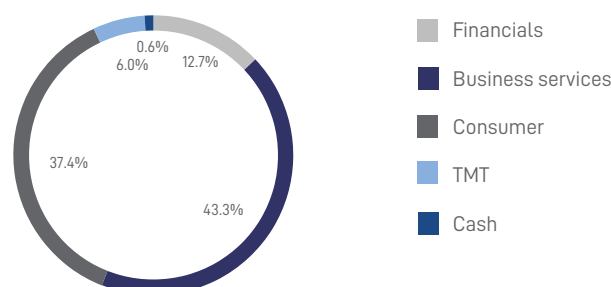

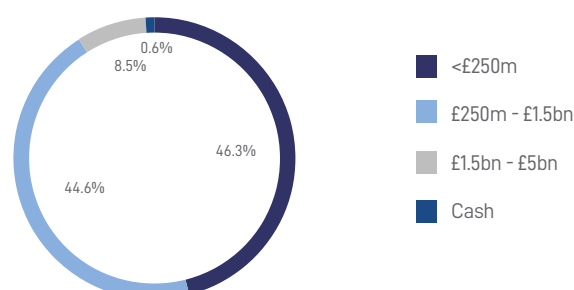
