## **Business Overview**

Gresham House is a specialist alternative asset manager providing funds, direct investments and tailored investment solutions, including co-investment across a range of highly differentiated alternative investment strategies. Our expertise includes strategic public, private equity (private assets), timber, renewable energy, housing and infrastructure. We aim to deliver sustainable financial returns and we are committed to building long-term partnerships with our clients to help them achieve their financial goals.

From a standing start in December 2014, through a combination of acquisitions and organic growth, the Gresham House business has grown exponentially, with assets under management now at c.£4.0 billion, (31 December 2020), providing a strong and scalable platform from which to continue to grow. The team is delivering on its objectives and now has c.120 employees working in London, Oxford and Perth in Scotland.

### **Role Objective**

Gresham House is growing its assets under management and a key strategic pillar within this is the Housing investment vertical. The Housing investment team are currently investing from two funds and are currently raising capital for a further two funds; all funds invest directly residential property assets and are long-term owner/operators for the assets.

The Housing Division already manage  $\sim$ £700m of gross assets comprising  $\sim$ 4,000 homes with an ambition to double this number over the coming 2-3 years. To support this growth the investment team are seeking to add an experienced investment professional to the team.

The proposed Associate Director will report directly to one of the Lead Fund Managers within the Housing division and ultimately act as a named Deputy Fund Manager.

### Key Responsibilities / Accountabilities

The role is divided into four main areas:

1. **Investment execution and management (50%):** The Associate Director will be expected to work closely with the origination team and external stakeholders to ensure the delivery of key investments. They will be the "owner" of specific investments and be responsible for:

- Review of internal opportunities presented by the origination team
- Preparation and review of transaction specific investment models
- Liaising with, appointing and managing external advisors during the due diligence process
- Review of transaction specific due diligence and data room
- Attending and leading project meetings
- Ensuring internal investment committee and board approvals are in place (including the drafting and presentation of internal investment papers)
- Manage internal financial models
- 2. **Fund/Investment strategy (20%):** Working with the lead fund manager and divisional heads to prepare and articulate the fund investment strategy; this will include:
  - Preparation of internal returns and taking ownership for the delivery the teams' strategy
  - Take ownership for strategic initiatives within the division (for example building on our existing customer / environmental charters)
  - Representing Gresham House at industry events to build the fund's profile and origination network
  - Performing ad hoc research into new market developments for the lead fund manager and divisional management
- 3. **Presenting to investors (20%):** Working to support the lead fund manager with communications to current and potential investors:
  - Preparation of financial models to support forecasts
  - Assisting in the preparation of investor reports
  - Collation and review of management information and analysis of KPIs
- 4. **Business support (10%):** Support the wider business in engaging with various counterparts including the development of junior team members.
