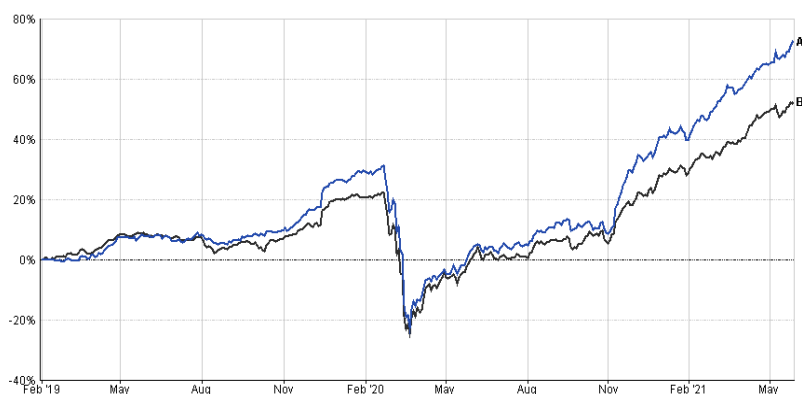
## Fund objective

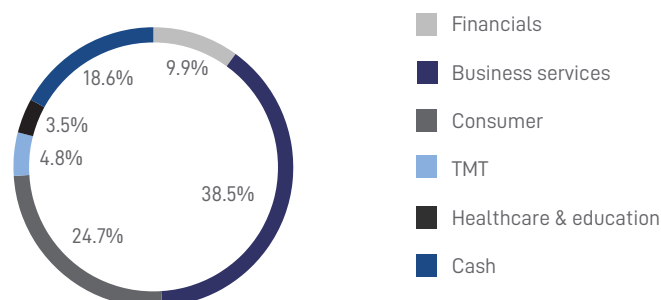

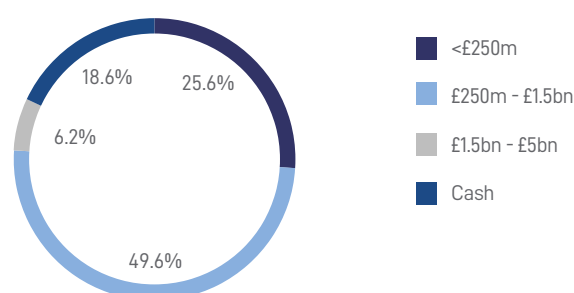
