## Sustainable Investment Policy

### Connecting our purpose with a commitment to Sustainable Investment

#### Our business purpose is to

Deliver effective and alternative investment solutions to ensure clients achieve their financial objectives whilst making a meaningful contribution to advancing the world's transition to a more sustainable way of life.

#### Our definition of sustainable investment is

Investment that proactively manages a full range of risks and seeks to make a positive social, economic or environmental impact whilst delivering strong financial returns.

#### We believe our commitment to

Integrating sustainable investment practices across our strategies has a clear fit with making an active contribution to the sustainability agenda at a global, local and asset level over the long term.

Meeting the challenge of climate change and the Sustainable Development Goals:

In making our commitments we are mindful of the many significant drivers to the sustainability agenda, especially the **impact of climate change** which we regard as a critical priority for business to address. We believe that investments in a number of our asset classes are creating tangible positive action towards meeting this global challenge.

Many investments within our real asset classes also have a good alignment with delivering a number of the **UN's Sustainable Development Goals**, which we will continue to identify, optimise and evaluate.

We believe in playing an industry leadership role in supporting and promoting sustainable investment, including through participation in a number of industry bodies. We are a signatory to the UN-supported **Principles of Responsible Investment (PRI)** and have aligned our sustainable investment commitments with them. We are also a member of **UKSIF** and a signatory to the **UK Stewardship Code**.

### Our sustainable investment commitments

We will endeavour to:

- Take steps to consult and understand the views, concerns and ambitions of our stakeholders in seeking sustainable outcomes from the investments we are involved in.
- Integrate Environmental, Governance, Social and Economic benefit considerations into our selection, evaluation, governance and engagement processes across the lifecycle of each investment. We drive rigour and consistency in this by applying our sustainable investment framework and system, including clearly defined processes and expert ESG Decision Tools and methods.
- Ensure our team understands the imperative for effective ESG management and is empowered and equipped to carry this out through management support and training.
- Conduct regular monitoring of ESG risks, opportunities and performance in our investments and over time, reporting to our investors.
- Conduct our business activities in line with the UN-supported Principles for Responsible Investment, including an annual report of our progress towards implementation.

## How our policy will be driven and delivered

### Management commitment

Our senior management teams, including the various subsidiary Boards and the Group Management Committee (GMC), are committed to the implementation of this policy and to making appropriate resources and support available to our team to do so. We will conduct a regular review of our approach and how well we are meeting our commitments and will update this policy accordingly. The Board Sustainability Committee oversees and reviews the Corporate Sustainability Strategy.

### Sustainability Executive Committee

We have established a Sustainability Executive Committee within Gresham House whose remit is to drive sustainability-related deliverables, to ensure the business, its staff and the investments made demonstrate best practice and leadership. The Committee also owns delivery and oversight of the Corporate Sustainability Strategy and aims to elevate responsibility for sustainability to executive level, reflecting the importance and materiality of sustainability to the business.

The Committee is chaired by the Director, Sustainable Investment and has representatives from the GMC as well as heads of investment divisions and other group divisions such as sales, marketing and compliance to ensure that there is full integration and consistent application of our over-arching policy with our asset level policies and reporting deliverables. The Committee seeks external expert advice and guidance as needed.

### Training and capabilities

Within the Gresham House team we have significant depth of understanding of the specific ESG matters as they apply to the investment areas we specialise in, and we will continue to support the development of this expertise. The Sustainable Investment team leads sustainable investment related work across the business to ensure our policies and processes are implemented and to support the development of new sustainable investment strategies.

We will also invest in training our wider teams in the drivers and practice of sustainable investment and the implementation of our commitments. We will facilitate this through training led by internal individuals or external experts, as well as debate within and between our teams.

## Commitment to being a sustainable operator ourselves

Our Corporate Sustainability Strategy supports our ambition to become a recognised leader in sustainable investment and to lead by example through our internal commitments to sustainability as a Sustainable Investor, as a Sustainable Business & Employer and as a Sustainable Corporate Citizen. The first pillar, Gresham House as a Sustainable Investor, ensures that we continue to implement best practice policies and processes with regards to sustainable investment across all asset divisions. The latter two pillars define the steps we take to better understand our own sustainability footprint as an organisation and to use ESG management interventions in our own operations to make progress and show leadership within our industry.

### Executable strategies

Our asset classes vary considerably in terms of the nature of investment and business activity, and in particular in relation to opportunities to influence board and management attitudes and decisions towards long term sustainable outcomes. For this reason, just as our investment strategies themselves are tailored across our asset classes, we have adopted differentiated ESG integration strategies designed to be both practical and meaningful in context and that we believe will promote engagement by all concerned.

### Evaluation

We will evaluate the implementation of our commitments and strategies in a number of ways, including relevant KPIs chosen to evidence direct impact, changes in performance, and where possible a measure of where we believe we have influenced better or faster progress towards greater sustainability.



# Sustainable Investment Framework application

We use a thematic framework to structure analysis, monitoring and reporting of ESG issues and opportunities within the lifecycle of our investments as an aid to more consistent integration. Within our sustainable investment system our expert ESG Decision Tools help us identify the most material sub-themes within the broader framework where we believe we should be directing our focus towards more sustainable outcomes.
