Notice of Annual General Meeting 2025 ("AGM")

I am pleased to enclose the Company's Notice of AGM, which will be held on Wednesday, 12 March 2025 at 1.30pm at Saddler's Hall, 40 Gutter Lane, London, EC2V 6BR, following a shareholder event from 10.30am. The Notice of AGM, which follows this letter, sets out the business to be considered at the meeting. The purpose of this letter is to explain certain elements of that business to you.

Meeting Arrangements

The Board recognises that the Company's AGM represents an important forum for shareholders to ask questions and understands that attending in person may not be possible for all who wish to attend. We encourage all shareholders, whether or not they propose to attend the AGM, to exercise their votes by submitting their proxy electronically or by post no later than 1.30pm on 10 March 2025. Shareholders who wish to appoint a proxy are recommended to appoint the Chair of the AGM as their proxy. All valid proxy votes will be included in the polls to be taken at the meeting.

Your votes do matter. Proxy instructions (which explain how to lodge proxies electronically) are set out below.

Shareholders are invited to attend the 2025 Baronsmead Shareholder event & AGM from 10.30am on Wednesday, 12 March 2025. The shareholder event starts with a welcome reception at 10.30am, followed by a shareholder presentation at 11.00am. There will be a break for lunch and refreshments at 12.30pm followed by the Baronsmead Venture Trust AGM from 1.15pm and finally, the Baronsmead Second Venture Trust AGM at 1.30pm.

The formal business of the Company's AGM will commence at 1.30pm.

We endeavour to publish responses to the questions received in advance on our website, ahead of the proxy voting deadline.

Resolution 1- To receive the Annual Report and Financial Statements for the year ended 30 September 2024

The Directors are required to present the Strategic report, Directors' report, Auditor's report and the financial statements for the year ended 30 September 2024 to the meeting. These are contained in the Company's Annual Report and Financial Statements for the year ended 30 September 2024 (the "2024 Annual Report").

Resolution 2 – To declare a final dividend

The Board proposes a final dividend of 2.25 pence per share in respect of the year ended 30 September 2024. If approved, the recommended final dividend will be paid on 17 March 2025 to all ordinary shareholders who are on the register of members on 14 February 2025. The shares will be marked ex-dividend on 13 February 2025.

Resolution 3 – To receive and approve the Directors' Remuneration Report

Under section 420 of the Companies Act 2006 (the "Act"), the directors must prepare an annual report detailing the remuneration of the directors and a statement by the chair of the remuneration committee (together, the "Directors' Remuneration Report"). The Act also requires that a resolution be put to shareholders each year for their approval of that report. The Directors' Remuneration Report can be found on pages 56 to 60 of the 2024 Annual Report. Resolution 3 is an advisory vote only.

Resolution 4 – To Approve the Directors' Remuneration Policy

To approve the directors' remuneration policy, which has been amended to include a broader range of companies, when the Directors review remuneration. The current policy is included below, and the proposed amendment is included in brackets:

The Board's policy is that the remuneration of Non-Executive Directors should reflect the experience of the Board as a whole, be fair and comparable to that of other relevant venture capital trusts [and investment companies, in particular those] that are similar in size and have similar investment objectives and structures.

Furthermore, the level of remuneration should be sufficient to attract and retain the Directors needed to oversee properly the Company and to reflect the specific circumstances of the Company, the duties and responsibilities of the Directors and the value and amount of time committed to the Company's affairs.

As highlighted in the Annual Report on page 58, the Board does not intend to make any significant changes to the remuneration, or the way it is reviewed, should the proposed amendment be approved – the Board is simply seeking to formally include a wider range of similar companies when considering Directors' fees in future.

Resolutions 5 to 8 – To elect and re-elect the Directors

In accordance with the Articles of Association, any new Directors will offer themselves for election at the first AGM following their appointment. In line with the AIC Code of Corporate Governance, the Nomination Committee has agreed that all Directors will stand for re-election on an annual basis. Therefore, Adriana Stirling, who was appointed on 1 December 2024, will be standing for election and Sarah Fromson, Graham McDonald and Tim Farazmand will retire and being eligible, offer themselves for re-election. Malcolm Groat will retire from his role as a Non-Executive Director on 31 December 2024.

The Board confirms that the performance of each Director seeking election or re-election continues to be effective and that each Director demonstrates commitment to their role. The Board believes that it is therefore in the best interests of shareholders that each Director be re-elected.

The Directors also believe that the Board includes an appropriate balance of skills, experience and knowledge. Full biographies of all Directors standing for election and re-election are set out on pages 5 to 6 of this document.

Resolutions 9 and 10 – To re-appoint BDO LLP as Auditor of the Company, to hold office until the conclusion of the next general meeting at which the accounts are laid before the Company and to authorise the Audit & Risk Committee to determine the remuneration of BDO LLP

At each meeting at which the Company's accounts are presented to its members, the Company is required to appoint an Auditor to serve until the next AGM. The Board, on the recommendation of the Audit & Risk Committee, recommends the reappointment of BDO LLP. Resolution 10 gives authority to the Audit & Risk Committee to determine the Auditor's remuneration.

Resolution 11 – To authorise the Directors to allot ordinary shares

The authority proposed under Resolution 11 will authorise the Directors, until the conclusion of the AGM held in 2026 or 15 months from the date of passing this resolution, whichever is earlier, to allot shares in the Company or grant rights to subscribe for or convert any security into shares in the Company up to an aggregate nominal amount of £19,583,511 representing 50 per cent of the issued share capital of the Company (excluding treasury shares), as at 23 December 2024. Any consequent increase in the size of the Company will, in the opinion of the Directors, be in the interests of shareholders generally. Any issue proceeds will be available for investment in line with the Company's investment policy and may be used to purchase ordinary shares of the Company.

The Directors intend to use this authority for the purposes described under Resolution 12.

Resolution 12 – To authorise the Directors to disapply pre-emption rights

Resolution 12 renews and extends, subject to the passing of Resolution 11, the Directors' authority to allot equity securities for cash without pre-emption rights in certain circumstances. This resolution will authorise the Directors, until the date falling 15 months after the date of the passing of the resolution or, if earlier, the conclusion of the next AGM of the Company, to issue ordinary shares for cash without pre-emption rights applying of: (i) up to an aggregate nominal amount representing 30 per cent of the Company's issued share capital (excluding shares held in treasury) as at the date of the passing of the resolution pursuant to one or more offers for subscription (for illustrative purposes only; had Resolution 12 been passed as at the date of this notice, this authority would have applied to 117,501,068 shares, being 30 per cent of the Company's current issued share capital (excluding shares held in treasury)); (ii) up to an aggregate nominal amount representing 10 per cent of the Company's issued share capital (excluding shares held in treasury) as at the date of the passing of the resolution pursuant to a dividend reinvestment scheme (which may be at a discount to NAV); and (iii) up to an aggregate nominal amount representing 10 per cent of the Company's issued share capital (excluding shares held in treasury) as at the date of the passing of the resolution (which may be at a discount to NAV) for allotments from time to time (for illustrative purposes only; had Resolution 12 been passed as at the date of this notice, this authority would have applied to 39,167,023 shares, being 10 per cent of the Company's current issued share capital excluding treasury shares).

This power will be exercised only if, in the opinion of the Directors, it would be in the best interests of shareholders as a whole.

Resolution 13 – To approve the purchase of the Company's own shares

The current authority of the Company to make market purchases of up to approximately 14.99 per cent of its issued share capital, granted at last year's AGM expires shortly. Resolution 13 seeks renewal of such authority until the next AGM (or the expiry of 15 months after the passing of the resolution if earlier). The price paid for shares will not be less than the nominal value nor more than the maximum amount permitted to be paid in accordance with the rules of the Financial Conduct Authority in force as at the date of purchase. This power will be exercised only if, in the opinion of the Directors, a repurchase would be in the best interests of shareholders as a whole. Any shares repurchased under this authority will either be cancelled or held in treasury at the discretion of the Board for future re-sale in appropriate market conditions.

The authority sought would replace the authority previously given to the Directors. The maximum number of ordinary shares authorised to be purchased pursuant to the authority represents approximately 14.99 per cent of the total number of ordinary shares in issue as at the date of the passing of this resolution (excluding any ordinary shares held in treasury).

Resolution 14 – Notice period for general meetings

Under the Act, the notice period required for all general meetings of the Company is 21 clear days. AGMs will always be held on at least 21 clear days' notice, but shareholders can approve a shorter notice period for other general meetings.

The Board believes that it is in the best interests of shareholders of the Company to have the ability to call meetings on no less than 14 clear days' notice should a matter require urgency. The Board is therefore proposing Resolution 14 to approve the reduction in the minimum notice period from 21 clear days to 14 clear days for all general meetings other than AGMs. The Directors do not intend to use less than 21 clear days' notice unless immediate action is required.

Board recommendation

The Directors believe that the resolutions contained within the Notice of AGM are in the best interests of the Company and shareholders as a whole and unanimously recommend that shareholders vote in favour of them, as the Directors intend to do in respect of their beneficial shareholdings. As at 23 December 2024, the total beneficial shareholdings held by the Directors were 602,855 ordinary shares, which represented 0.15 per cent of the total voting rights.

Appointed: 1 October 2019

Sarah is an experienced, independent non-executive who has served on a variety of boards and committees, after a varied career in the asset and wealth management industry. She is a non-executive board member of Boston-based Arrowstreet Capital Partners and is also a Pension Trustee Director of Genome Research Pensions Trustee Limited and Wellcome Trust Pensions Trustee Limited. She chairs the Cambridge University Endowment Fund Investment Advisory Board and also serves on the board of Quilter Investors Ltd, a subsidiary of Quilter plc. In March 2023, Sarah became an Advisory Member of the Investment Committee to Calouste Gulbenkian Foundation, a Lisbon-based entity. Sarah retired from her executive role as Head of Risk at Wellcome Trust in 2019 and as Chair of JP Morgan Global Emerging Markets Income Trust plc in 2022. Sarah was previously Chief Investment Risk Officer at RBS Asset Management (formerly Coutts).

Sarah has a range of experience for her role as Chair of the Board and Chair of the Nomination Committee. Graham McDonald (Senior Independent Director)

Appointed: 16 February 2021

Graham has spent almost 40 years in banking and private equity. His previous executive role was Global Head of Private Equity and Venture Capital at Aberdeen Standard Investments. Prior to that he was responsible for the global private equity and venture capital businesses in Aberdeen Asset Management, SWIP, Lloyds Bank and HBoS. He is Strategic Advisor to Par Equity LLP. Graham stepped down from his position as Chair of Continulus Limited in August 2023 and as advisor to Arcano Capital Partners and Vedra Partners in December 2022 and April 2023, respectively.

- 7. A person authorised by a corporation is entitled to exercise (on behalf of the corporation) the same powers as the corporation could exercise if it were an individual member of the Company. On a vote on a resolution on a poll, if more than one authorised person purports to exercise power in respect of the same share:
 - (a) if they purport to exercise the power in the same way as each other, the power is treated as exercised in that way; or
 - (b) if they do not purport to exercise the power in the same way as each other, the power is treated as not exercised.

- Any person receiving a copy of this Notice as a person nominated by a member to enjoy information rights under section 146 of the Companies Act 2006 (a "Nominated Person") should note that the provisions in Notes 2 and 3 above concerning the appointment of a proxy or proxies to attend the meeting in place of a member, do not apply to a Nominated Person as only Shareholders have the right to appoint a proxy. However, a Nominated Person may have a right under an agreement between the Nominated Person and the member by whom he or she was nominated to be appointed, or to have someone else appointed, as a proxy for the meeting. The termination of the authority of a person to act as a proxy must be notified to the Company in writing. Amended instructions must be received by The City Partnership (UK) Ltd by the deadline for receipt of proxies. The total number of treasury shares held by the Company represents 11.68 per cent of the Company's issued share capital (excluding treasury shares). The total number of voting rights in the Company is 391,670,228.

- 13. A copy of the Notice of AGM and the information required by Section 311A Companies Act 2006 is included on the Company's website, www.baronsmeadvcts.co.uk.
- 14. Section 319A of the Companies Act 2006 requires the Directors to answer any question raised at the AGM which relates to the business of the meeting, although no answer need be given: (a) if to do so would interfere unduly with the preparation of the meeting or involve disclosure of confidential information; (b) if the answer has already been given on the Company's website; or (c) if it is undesirable in the best interests of the Company or the good order of the meeting.
- 15. A resolution may properly be moved at the AGM unless: (i) it would, if passed, be ineffective (whether by reason of any inconsistency with any enactment or the Company's constitution or otherwise); (ii) it is defamatory of any person; or (iii) it is frivolous or vexatious. A request made pursuant to this right may be in hard copy or electronic form, must identify the resolution of which notice is to be given, must be authenticated by the person(s) making it and must be received by the Company not later than six weeks before the date of the AGM.
- 17. Members satisfying the thresholds in section 338A of the Companies Act 2006 may request the Company to include in the business to be dealt with at the AGM any matter (other than a proposed resolution) which may properly be included in the business at the AGM. A matter may properly be included in the business at the AGM unless (i) it is defamatory of any person or (ii) it is frivolous or vexatious. A request made pursuant to this right may be in hard copy or electronic form, must identify the matter to be included in the business, must be accompanied by a statement setting out the grounds for the request, must be authenticated by the person(s) making it and must be received by the Company not later than six weeks before the date of the AGM.
- 18. By attending the meeting, members and their proxies and representatives are understood by the Company to have agreed to receive any communication relating to the Company's shares made at the meeting.
- 19. CREST members who wish to appoint a proxy or proxies by utilising the CREST electronic proxy appointment service may do so for the meeting and any adjournment(s) thereof by utilising the procedures described in the CREST manual, which is available to download from the Euroclear website (www.euroclear.com). CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.

- 20.
