

Performance

In November 2025, the WS Gresham House UK Micro Cap Fund decreased by 2.1%, slightly underperforming the IA UK Smaller Companies sector, which decreased by 1.9%.

Positive contributions came from: ActiveOps (+0.5% Contribution to Total Return ("CTR")) buoyed by a strong interim update which reported significant growth in annual recurring revenue and a doubling of adjusted EBITDA, reflecting accelerating demand for its Decision-Intelligence software and widening enterprise adoption, alongside inorganic contribution from the acquisition of Enlighten; Ten Lifestyle (+0.5% CTR) after its full-year 2025 results revealed improved profitability and accelerated 'active' membership penetration, a leading indicator for organic growth; and TruFin (+0.3% CTR) on no specific company news flow during the period.

The largest detractors were: Angling Direct (-0.5% CTR) despite no specific company newsflow during the period and having upgraded full-year expectations in October; Mpac (-0.5% CTR) also despite no specific company newsflow; and Bigblu Broadband (-0.4% CTR), following the company's announcement of its intentions to cancel its AIM admission.

Portfolio activity

The Fund made one new investment during the period, into; **Winvia**, a UK-based, technology-led entertainment company that operates prize draws, skill-games competitions, and online gaming platforms. In November, Winvia completed an initial public offering on the AIM market of the London Stock Exchange, raising approximately £40 million to support growth and strategic acquisitions.

The Fund made one full exit during the period, from; **Bigblu Broadband** following the announcement that it plans to delist from the public market and the warning that it may receive no further proceeds from the contingent consideration tied to the sale of its subsidiary SkyMesh.

1. Fund statistics definitions

Volatility is a statistical measurement that, when applied to an investment fund, expresses its volatility, or risk. It shows how widely a range of returns varied from the fund's average return over a particular period.

Alpha is a measure of a fund's over-orunderperformance in comparison to the benchmark of the fund. Alpha represents the extra value the manager's activities have contributed, the greater the alpha, the greater the outperformance.

Beta is a statistical estimate of a fund's volatility in comparison to its benchmark. It depicts how sensitive the fund is to movements in the section of the market that comprises the benchmark.

Sharpe is the level of a fund's return over and above the return of a notional risk-free investment, such as cash or government bonds. The difference in returns is then divided by the fund's standard deviation (volatility). This is an indication of the amount of excess return generated per unit of risk. In general it is considered that the higher the Sharpe ratio, the better.

Information ratio is a risk-adjusted measure of actively managed fund performance. It assesses the degree to which a manager uses skill and knowledge to enhance the fund returns. The higher the information ratio, the better. It is generally considered that a figure of 0.5 reflects a good performance, 0.75 very good, and 1 outstanding.
